



Waiver of Claims, Release of Liability and Assumption of Risk

- 1. I understand and am aware that tennis, swimming, strength, flexibility, and aerobic exercise, including use of equipment, is potentially hazardous and understand that such activities involve a risk of injury and even death and that I/we am/are voluntarily participating in these activities and using facilities, equipment, and machinery with knowledge of the dangers involved. I hereby agree to expressly assume and accept any and all risks of injury or death.

I understand and agree that all minors under the age of 13 will always have adult accompaniment at the pool and a minor cannot be responsible for another minor at any time.
